

# Girls and Boys Sand Doubles Volleyball League Tuesday Nights at Dale's Weston Lanes



Join us on Tuesday nights for the 8th annual sand doubles volleyball youth league at Dale's Weston Lanes! We have 3 beautiful sand courts around the back of the bowling alley. Food and drinks are available to order at the cabana! Bring the family for a fun summer night out :)

**New this year:** Current 4th-7th grades will get instruction on how to play the beach game, practice beach drills and compete in doubles matches with a variety of partners each night. We will give instruction for the first half, and play games the second half of each session. Attendance for each session is optional. Come as your schedule permits.

**Teams: 8th -13th grades** Can be same-sex or co-ed. Boys and girls will be playing against each other. Maximum of 3 players per team. Teams are responsible for attending, or providing substitutes for each play date. There is a \$35 penalty for any team that fails to do so. Substitutions are flexible and anyone in their division can play for each other. With permission from the director, players outside of the league may also substitute.

**When:** June 5th, 12th, 19th, 26th; July (no league July 3rd) 10th, 17th, 24th, 31st. Start times are approx. 4-10pm. NO JULY 3rd

**Grades:** Youth- Current 4th-7th grades. Intermediate and Advanced- 8th-13th grade.

**Format:** Round robin to seed for the tournament on July 31st. Division winners get t-shirts.

**What to bring:** Sunglasses, towel, comfortable athletic clothing, water bottle, and sunscreen. Beach volleyballs will be provided.

**Registration:** Youth 4th-7th grades sign up individually. All other grades sign up as a team.

**Weather:** Prepare for all kinds of weather. We will play in windy, cold and light rain, and delay for lightning. Games will not be rescheduled.
